



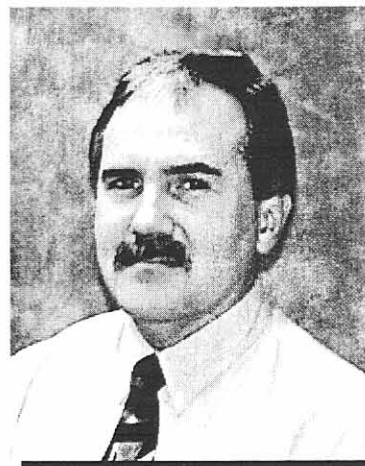
A Message from the President

Work is in high gear for the 40th Annual Training Conference being held in Melbourne October 24-28, 1999. This is still the most popular state division conference anywhere in the country.
